Allison Williams, NOMA FAIA, Principal & Design Director, Perkins + Will - San Francisco

Ms. Williams is a principal and director of design for the San Francisco office of Perkins+Will, an architectural design firm with 20 offices around the world. Her 30-year career has been focused on the design of large-scale, mixed-use civic projects in urban contexts. She has held design leadership roles in numerous award-winning firms. Ms. Williams, one of America's few Black architects practicing in the design of significant civic buildings and cultural facilities became a subject of national media attention after winning the invited design competition for the August Wilson Center for African American Culture in Pittsburgh PA in 2003. Williams has been featured in several publications including The Wall Street Journal (November 5, 2003), U.S. News & World Report (December 29, 2003), The New York Times (June 24, 2004), Black Enterprise magazine (May 2005) and Ebony Magazine (October 2005) and her work was recently included in an exhibition at the Museum of Science and Industry in Chicago. Ms. Williams earned her undergraduate and Master of Architecture degrees from the University of California, Berkeley, and was a Loeb Fellow at the Harvard Graduate School of Design.

Andres Quintana, Esq. is the principal attorney at the Quintana Law Group, APC, a full service civil litigation firm which specializes in intellectual property matters. Mr. Quintana has extensive experience in intellectual property litigation both at the trial and appellate levels. He has also published several works on intellectual property, including on architectural copyright protection. Mr. Quintana received his bachelor's and law degrees from U.C. Berkeley. He is a former experienced trial attorney with the U.S. Department of Justice in Washington, D.C., where he received a Special Achievement Award by the Attorney General of the United States. Prior to commencing the Quintana Law Group, Mr. Quintana was a litigation and intellectual property partner at Ervin, Cohen & Jessup, a well-known Beverly Hills law firm. Mr. Quintana was selected as a "2006 Southern California Rising Star" by Los Angeles Magazine, recognizing him as one of the top up-and-coming lawyers in Southern California.

Mr. Bryant is the executive director of Row House Community Development Corporation, a nonprofit focused on housing and innovative design, and sister organization of Houston's award-winning Project Row Houses. Antoine appreciated the closeness of his urban neighborhood, but wanted to make a difference in his physical environment. Antoine Bryant has worked in a variety of genres in the analysis, design and development of affordable housing. Antoine earned his Bachelor of Science in urban and regional studies from Cornell University and did his graduate architectural training from the University of Texas at Austin. He has worked in architectural design and development of housing in the San Francisco Bay Area and in Austin and Houston, Texas. He is the Vice President of Houston NOMA and the NOMA University Liaison Southwest.
